2. COMPOSITION / INFORMATION ON INGREDIENTS

Hazardous ingredients: CO/AL MIXED OXIDE >90%

3. HAZARDS IDENTIFICATION

Main hazards: No significant hazard.

Skin contact: There may be mild irritation at the site of contact.
